

STUDENT FEES REGULATION

Art. 1 - Student fees

The student fee is composed of:

Annual Enrolment Fee¹ **500 € VAT included**

Tuition Fee **Variable, according to income bracket**

Annual Fee for Supplementary years Enrolment²: 3.000 €

Art. 2 - Method of payment

All the fees must be paid into the following bank account:

Art. 3 - Tuition Fee

- A. For three-year courses, there is a differentiated tuition fee based on 5 income brackets, commensurate with the student's family's economic and financial circumstances.
- B. The income bracket (and consequently the Tuition Fee) is established by submitting **the ISEE Universitario / ISEE Parificato certificate** to the Academic Office annually within the following deadlines:
 - a. First year: by 15 October
 - b. Subsequent years: by 30 September
- C. Students who do not submit ISEE certification must pay the Tuition Fee according to the highest income bracket. All certificates that do not comply with the above indications will not be taken into account for the purposes of reducing the contribution.
- D. The income bracket is determined on an annual basis.

² Supplementary year enrolment: this occurs when a student has not completed all examinations by the end of the third academic year (30 September). If a student has completed all examinations by 30 September but has not discussed the Final Work, he/she does not have to re-enrol.

Art. 4 - Tuition Fee Reduction

a. **Tuition fees** may be reduced through **discount shares** or the assessment of particular family aspects as defined below. The benefits listed below cannot be combined with each other or with any scholarships. In the event that the student is entitled to more than one benefit, the benefit that is most favourable to him/her will be taken into account, unless the student indicates otherwise. All benefits are applied to the entire tuition fee, but recognised as a deduction from the payment of the second instalment.

b. **Family members** enrolled in Accademia Unidee: 10% discount.

For siblings or spouses simultaneously enrolled in Accademia Unidee's three-year or master's courses, there is a 10% reduction in tuition fees. The request must be made at the time of enrolment and must be made by indicating the relationship on the "Supplementary Family Declaration", which can be obtained from the academic office. In any case, the reduction operates from the year in which the request is submitted.

c. **Relatives of Pistoletto Foundation employees**: 35% discount.

The request must be made at the time of enrolment and must be made by indicating the relative on the 'Supplementary Family Declaration'.

d. **Disabled students**: 100% exemption

Students who certify a recognised handicap and/or disability of 66% or more are exempt from paying the full cost of tuition fees.

Art. 5 - Scholarships

Thanks to the Pistoletto Foundation's commitment, in line with its mission and philosophy, and also thanks to its wide network of national and international partners, Accademia Unidee annually makes a considerable number of scholarships available to the most deserving and motivated students, the call for which can be found on the website.

Art. 7 - Indemnity for late payment

The indemnity for late payment is 20% of the amount due, unless otherwise determined by the Academic Council.

Art. 8 - Enrolment on individual courses

It is also possible to enrol in individual courses, both for former students of the Academy and for non-enrolled students. In this case, the enrolment fee for the academic year 2025/2026 is 200 euros per ECTS (CFA eq.).
